In June 2014, I was appointed as the MSN Program Director. In this role, I maintain responsibility for the multiple tracks of the Masters of Science in Nursing program, including Family Nurse Practitioner, Emergency Nurse Practitioner, Psychiatric-Mental Health Nurse Practitioner, Adult Gerontology Acute Care Nurse Practitioner, RN to MSN program, MSN Informatics Specialization, MSN Clinical Nurse Educator, and MSN Leadership in the Healthcare System. The masters programs are offered in a ground-based and online format. Primary responsibilities of the role include oversight of curriculum development, revision, and instructional design of all program tracks. Since being appointed Director, I have overseen the development and approval of the RN to MSN, BSN to DNP, Adult Gerontology Acute Care Program, Psychiatric Mental-Health Program, and multiple post graduate certificates including education, leadership, informatics, and specialty nurse practitioner certifications. I worked diligently to develop new community partnerships which has resulted in consistent clinical placements for our nurse practitioner students. In this role, I maintain responsibility for the development and operations of online graduate programming from multiple disciplines to include nursing, health informatics, sport management, and business programs. In addition working closely with program directors, I collaborate with the Academic Technology and Instructional Design teams to develop innovative curriculum design and delivery.
